### **Executive Summary**

This paper summarises the latest position in terms of rentals and levels of debt from tenants.



#### Tenant Update - SBUEL Board July 2019

- Progress with moving tenants onto the new leases has been successful, with only two outstanding that should be completed by the end of July. All leases are held centrally by GovLegal.
- As yet, we have not secured agreement from the Executive to finance the necessary refurbishment and upkeep of the Clarence Centre. This investment was originally requested through the Align process but has now gone back to the Executive. Without this investment, rents will stagnate and income will not be achieved in line with agreed forecasts
- The 8<sup>th</sup> Floor of the Keyworth Centre was handed back to the University on 17<sup>th</sup> June as part of the Estates redevelopment. There will be a shortfall in the Venue hire income target for 18/19 and 19/20 as a result.
- Tenant engagement continues to accelerate with 25 companies engaging on 46 occasions. Recent instances include providing keynote speeches for the PGR Summer School and Celebrate Enterprise event and a KTP through the School of Engineering.

#### Included with this update are two documents:

- Tenant breakdown showing occupancy and rental value.
- Breakdown of tenant arrears as of 17th July 2019. Key points to note:
  - o Overall arrears up £55K on 17/18
  - 90+ day arrears up £29k on 17/18 due to a large tenant debt from an individual tenant. This tenant debt is being managed and will be cleared in August 2019.
  - 30-89 day arrears has increased by £24K in year but invoices are now being paid quicker.
  - Arrears is being more effectively managed between REI and the Income team within Finance through a clearer, consistent approach to non-payment.
