Neilcott Construction Group is an established business founded in 1967and based in Orpington, Kent and relocated to larger freehold premises still in Orpington in 2000. Neilcott opened a second regional base in Woking, Surrey in 2002 subsequently replaced by a larger base in Farnborough, Hants in 2007.

The company has always been principally involved in building contracting activities across a wide range of construction projects. This work covers commercial, design and build, education, healthcare, industrial, leisure, residential and retail sectors. Across these various sectors the company has a wealth of experience of working on listed buildings.

Neilcott established a special works division during 2002, primarily working within London and a development division in 2007. Neilcott Construction Group's turnover in year 2011 was £57m with a profit of £2.63m reported.

Its other operating subsidiaries trade under the Walls Group name across civil engineering, property and construction in Ireland. Walls Group being one of Ireland's top ten contractors in size, with a history stretching back to establishment 1950.
