Following the DfE governance review of the UTC, and the SBA Board meeting of 11 October 2018, the Board agreed to appoint an independent Chair of the Board and Chairs of the two School Advisory Boards (who will also be Trustees and members of the SBA Board).

The positions were advertised in October 2018 on these websites:

- Governors for Schools
- Inspiring Governance
- National Governance Association

LSBU and SBA's networks were also searched for appropriate candidates.

Three candidates applied and an additional candidate was approached.

Initial selection process

Four candidates met the Group CEO and Fiona Morey (LSBU PVC Compulsory & Further Education) for an informal discussion; and were then interviewed by the interim Chair of the Board, Business Manager (for the interim CEO) and an independent director.

Following this process, it was considered that none met the requirements for Chair of the Board. Chris Mallaband was recommended as Chair of a SAB (later confirmed Chair of the UAE).

Due to this outcome, LSBU and SBA networks were further searched for additional appropriate candidates. Hitesh Tailor was identified and following meetings with the Group CEO, Interim CEO and SBA Executive Principal, he is recommended for appointment as Chair of the Board.

Chair of UTC SAB

Following the identification of Chris Mallaband as Chair of the UAE SAB, it was proposed that Lesley Morrison, currently SBA director and local governor of the UAE, joins the UTC SAB as a local governor and Chair. As Chair of the UTC SAB she will remain as an SBA director, but step down as a local governor on the UAE SAB.

Profiles of the three recommended candidates are attached.

The Board is requested to approve with immediate effect:

- the appointment of Hitesh Tailor as a director and Chair of the SBA Board;
- the appointment of Chris Mallaband as a director and Chair of the UAE SAB;
